2026 Western Maryland Forage Conference

Pesticide Private Applicator Exam Review



The Garrett Office of University of Maryland Extension will be holding a private applicator test review on January 26th from 6-9pm at the Oakland office. The review will cover the information that is on the MDA Private Applicator Exam. Individuals that wish to have a private applicator license will also need to take the

exam with MDA. MDA has two options for the exam, it can be taken in person or online. A date will be set later in the winter for the exam to be taken live in Garrett County and information will be provided on how to take the exam on-line. The private applicator license is required for farmers who apply restricted use pesticides on property that they farm. The license does not cover spraying for hire for other farmers or businesses. The training session is free. Materials are available in print (for a fee) and online.

Winter Ban ON Spreading Manure Begins December 16, 2025



The Maryland Department of Agriculture is reminding farmers that the winter ban on spreading manure, food processing residuals (FPRs), and other nutrient sources on cropland begins on December 16, 2025. Farmers can resume spreading these materials on March 1, 2026, as long as they follow their nutrient management plan recommendations and ensure that fields are not saturated, snow-covered, or hard-frozen. Do You Need A Nutrient Management Plan?



Nutrient management planning for the 2026 growing season is upon us. This fall, all producers who requested a 2025 nutrient management plan should have received a letter and subsequent data collection information outlining what is needed for their 2026 plan update. Please complete the required information and return it to Andrea as quickly as possible. Any other producer in need of a plan who has not already contacted our office should call 301-334-6960 or email auphold@umd.edu as soon as possible. If soil and/or manure samples are needed for your plan update, please

take advantage of any break in the winter weather to obtain those samples instead of waiting until spring. Sampling materials are available at the extension office for you to send the samples yourself. Let us know if we can answer any questions and we look forward to working with you.

USDA Livestock Forage Disaster Program

The Livestock Forage Disaster Program (LFP) provides compensation to eligible livestock producers who have suffered grazing losses for covered livestock and who are also producers of grazed forage crop acreage of native and improved pasture land with permanent vegetative cover or acreage planted specifically for grazing. Grazing losses must occur on land physically located in a county experiencing a qualifying drought during the normal grazing period for the county. Garrett County producers are eligible for a payment in 2025 due to the dry weather throughout the summer.
