# Carroll County 4-H & FFA Information

We are closing in on our favorite week of the year...the 2025 Carroll County 4-H & FFA Fair! Take time before Fair week arrives to go through the schedule for all of the set-up times, entry times and events so your families are prepared beforehand. Double check all of the rules including the Fair general rules and individual department rules that 4-Hers in your household are preparing for. Read through the Maryland 4-H Code of Conduct as a reminder for appropriate behavior during the week. A copy has been attached to this *Tribune*.

Remember, the Fair relies on volunteers and EVERYONE'S help is needed for set-up, working food concessions/events throughout the week and clean-up afterwards. You will find opportunities in the next several blurbs for opportunities to sign up to volunteer. We will continue to send out reminders about more volunteer opportunities as they are shared with us.

Here are some important dates to put on your calendars to help with set-up and clean-up of the fair-grounds:

Fair Grounds Set-Up—Sunday, July 20th starting at 8am

Fair Grounds Clean-up—Saturday, August 2nd starting at 9am and Sunday, August 3rd

#### **Payment Policy Reminder**

NEW POLICY in regards to payments for county 4-H programs. We will be sending invoices to those who register for our programs that cost over \$5. As we plan programs, we work on making sure we can cover the cost of the supplies of the program and keep program costs as low as possible. We previously asked that families "pay at the door" for these programs. What we have been experiencing recently though is that some families are signing up for programs and then not attending without letting the office staff know of that change. We typically have 4-H members on a waiting list that would like to attend the program, but can't when we are unaware of someone not attending. Moving forward, if you register for a program that has a cost associated with it and do not show for the program, you are still responsible for paying for the program as supplies have already been purchased.



## Children's Day at the Fair

Attention all 4-H and FFA clubs! The Fair will once again be hosting Children's Day on Tuesday, July 29th, from 9:00 a.m. to 2:00 p.m., and we need your help! In previous years, more than 1,000 children have attended this event at the Carroll County Fair, and this success has been due to the participation of 4-H clubs, members, and volunteers!

We are asking that clubs sign up for a make-it and take-it craft table, as in the past, or to volunteer. The tables or stations can be a 2.5-hour or all-day (5-hour) time slot. If your club chooses to sign up for a craft, we ask that you prepare these crafts for either 350 participants (2.5-hour time slot) or 700 participants (all day). When preparing these games and crafts, we ask that you keep agriculture, healthy living, and 4-H in mind. Remember that these activities should engage our youth and encourage them to stay for the day! If you or your club would like to help with Children's Day, but cannot be at the event, we are also looking for donations! You could provide a monetary donation towards game prizes, a donation for goodie bags, or items such as face paints, crayons, etc.

We hope that your club will be able to participate in some way, as it will be a wonderful opportunity to promote and educate young children and their families about the great 4-H program and agriculture here in Carroll County! #### **Livestock Buyer Letters**

It's never too early to start contacting potential buyers for the livestock sale! Remember, it's <u>your</u> responsibility to find businesses and/or individuals to come to the sale and support your 4-H project. The more time you invest in finding a buyer, the more it may pay off for you at the sale!

Make sure to direct your buyers to the Livestock Sale webpage for more information on the sale. Remember, it's important for you to find your own buyer! Don't just count on someone being here to buy your animal.

### **Health Papers for Fair**

A reminder for all of our livestock families who will have health papers checked at the fair. Please remember to complete the Livestock Exhibitor's Self Certification of Animal Health form. If your health papers were hand written and on a pink carbon paper, the self certification can be found on the back of your health paper. If you have an electronic health paper, you will need to have the printed self certification form with your paper, which is attached to the online Tribune. Make sure that you have the back of the form completely filled out before you enter the fairgrounds. You are certifying that you have inspected your animals and they are healthy to come to the fair!

### **Maryland State Fair**

You can now enter for the Maryland State Fair! The entry system can be found at <a href="https://marylandstatefair.com/4hffa/">https://marylandstatefair.com/4hffa/</a> Please note that Maryland 4-H State Fair entries are due by July 15th! Don't miss the deadline for your state fair entries!

If you are planning to participate in the following events: **Dog Show, Fashion Revue, 4-H Presents, Top Chef, Dairy/Livestock/Poultry/Rabbit/Horticulture Judging or Dairy Goat Judging & Skills, Tractor Operator, Bicycle, Small Engines, Lawn Tractor....The majority of these state contests require that you qualify through a county event at the fair and may have other limitations. Please make sure you read the department rules. You MUST register through 4-H Online (v2.4honline.com) for these events. You are welcome to complete the registration process now, but your participation will not be approved on the county level until you have qualified (if required for contest). Please register by July 15th when you complete your other Maryland 4-H State Fair entries. Becky will approve those who can move forward to the state contest as those contest occur during the fair.** 

\*Note—Some of these events will have an associated registration cost. Please select **"Pay by Check"** and the Extension Office will cover those fees.

**Attention Club Leaders**—You will also need to follow these directions to enter your Club Booth and Club Banner. All banners are eligible to go to the state fair. Only two 4-H Club Booths can go to the state fair, so those entries will be approved once the county fair judging is completed.

### **Animal Quality Assurance**

If you are a new member or have moved to a new age group (Junior to Intermediate, Intermediate to Senior), you are required to take the online Quality Assurance Program this year. The online program is required for ALL 4-H members showing beef, dairy, swine, sheep, goats, horses/ponies, poultry, rabbits and alpacas/llamas. <a href="https://ahqa.umd.edu/">https://ahqa.umd.edu/</a> You will need to register and complete this program if you are planning to show at any 4-H animal show. Please print off the certificate at the end of taking AHQA. If the certificate prints and says "Guest," you were not signed into the website and will not receive credit. The certificate will have your name if completed correctly. If you have questions, please contact Becky at <a href="mailto:bridgewa@umd.edu">bridgewa@umd.edu</a>. Quality Assurance must be completed by Friday, July 18th to be eligible to show at the Carroll County 4-H/FFA Fair.

**Silent Auction**—The Carroll County 4-H & FFA Fair Silent Auction Committee is actively looking for donations for the fair silent auction. This is an important fundraiser for the fair as the funds raised help support the fair, but also help cover the cost of state contest fees for our 4-H members. **Fair Fundraiser**—The Fair will be selling tickets once again to support our 4-H and FFA members! There are 5 great prizes this year that you can win. The fair will once again be offering a pizza party to clubs that can sell more than 200 tickets. Tickets need to be given to Cindy Speak or a member of the fundraiser committee before fair starts to count towards the pizza party count. If interested in tickets, they can be picked up at the Extension Office or contact Cindy Speak.

Indoor Building Updates— The fair will be here soon. Are you ready? Make sure you check the fair schedule (found at www.carrollcountyfair.com). The fair starts on Friday, July 25th this year meaning 4-Hers will begin entering indoor exhibits on Wednesday, July 23rd. Departments that are entered on Wednesday include art, garden products and crafts. They will be dropped off—you will not talk to judges this year. We are suggesting that our craft exhibitors attach a 3x5 index card to explain your exhibit, otherwise what would you tell the judge about your project. This is not required, but a good idea if you want to add additional information for your project.

Club entries will be entered on Thursday, July 24th, including club books, booths & banners, service learning and shoebox floats. Booths and banners and shoebox floats will have conference judging with those entries. 4-Hers will also drop off their entries for home environment, family life and plants and flowers.

The Cake of the Year will be sold in the Inside Bake Sale. If you have only pre-registered 1 cake and you want a good chance at being in the cake auction, you might want to choose another cake that is eligible for the cake auction depending on the placing.

- 1. I am the **owner/authorized caretaker/transporter** (circle as applicable) of the animal(s) identified on the current, valid, "Certificate of Veterinary Inspection" (CVI) document.
- 2. I understand that animals showing any signs of, or having recent exposure to, contagious or infectious disease are not permitted to enter the fair/show premises. These conditions include but are not limited to the following:

	SKIN: Visible evidence of skin infections such as ringworm, warts, mange, lice, and club lamb
	fungus.
	HEAD: Discharge from the eyes or nose or evidence of soremouth, pinkeye, atrophic rhinitis,
	caseous lymphadenitis.
	RESPIRATORY: Infectious respiratory disease (pneumonia)
	INTESTINAL: Diarrhea
	FEET: Contagious hoof infections such as <i>footrot</i> . Exhibition of lame animals is discouraged.
	OTHER: Recent exposure to, or clinical signs of, any contagious or infectious disease
	conditions that would exclude livestock from exhibition.
